**To: All Creditors of GridWorks Lab, Inc., dba GridWorks IC (“GridWorks”) and Other Interested Persons:**

**NOTICE IS HEREBY GIVEN, that on December 18, 2019, the Circuit Court of the state of Oregon for Multnomah County in the above-captioned case entered a Stipulated Order Appointing Receiver (the “Order”). This Notice is provided pursuant to ORS 37.330 of the Oregon Receivership Code (the “Code”).**

The Order appoints Clyde A. Hamstreet & Associates, LLC as receiver (the “Receiver”) to exclusively possess, manage, and control the tangible and intangible assets of GridWorks (the “Property”) and to otherwise act as the Receiver for GridWorks as provided in the Order, to serve until further order of the court for the purposes described in the Order and the Code, including, but not limited to, taking control of the receivership estate with the power and authority to preserve, protect, and liquidate those assets and distribute proceeds to the party or parties legally entitled thereto.

1           **A. Notice of Automatic Stay.**

2           **NOTICE IS FURTHER GIVEN**, pursuant to ORS 37.220, that the entry of the Order  
3 operates as an automatic stay, applicable to all persons and entities, against most collection  
4 activities and the commencement or continuation of a judicial, administrative or other action or  
5 proceeding against GridWorks. This means that creditors generally may not take actions to  
6 collect debts from the Property or the receivership estate, or attempt to interfere with or exercise  
7 control over assets of the receivership estate. For example, while the stay is in effect, creditors  
8 cannot sue, repossess property, or otherwise try to collect from assets of the receivership estate.  
9 Persons who knowingly violate the stay may be required to pay actual damages, costs, and  
10 reasonable attorney fees incurred as a result of the violation. *See* ORS 37.220(7).

11           The terms of the Order also generally prohibit GridWorks, its members, agents, and  
12 representatives, from interfering in any way with the Receiver's custody and control of the  
13 receivership estate, or taking any actions that would damage, dissipate, impair, or prejudice the  
14 administration and/or the preservation of the assets of the receivership estate.

15           **B. Do Not File Claims at This Time.**

16           Under the terms of the Order, the Receiver is not required to establish a claims bar date or  
17 provide for a claims process for creditors holding unsecured claims unless the Receiver  
18 determines that there is a prospect of payment to such creditors after payment of the costs and  
19 expenses of the receivership (including authorized loans to fund the operations of GridWorks  
20 and pay the administrative costs of the receivership) and all claims secured by assets of the  
21 receivership estate. At this time, the Receiver does not believe there will be funds remaining for  
22 distribution to creditors holding unsecured claims at the conclusion of the receivership.  
23 **Therefore, at this time, creditors do not need to file a claim unless and until they receive**  
24 **further notice to do so. No claims may be submitted unless and until a claims process is**  
25 **first established by the Receiver.** If the Receiver later determines there will be assets available  
26 to pay unsecured claims, then unsecured creditors will receive further notice of a claims filing

1 deadline and instructions how to file a claim at that time.
